INVITATION TO INTERESTED PARTIES TO NOMINATE CANDIDATES FOR CONSIDERATION FOR APPOINTMENT ON THE EASTERN CAPE GAMBLING AND BETTING BOARD

Two vacancies have arisen in the board, consequently, interested parties are hereby invited to nominate candidates for consideration for appointment on the board by the responsible Member of the Executive Council in the categories mentioned below.

- (i) One member shall be a qualified as a chartered accountant in the Republic, who has been so qualified for a period of at least five years, and, for a cumulative period of at least five years after having so qualified, has practiced as a chartered accountant.

- (ii) One member shall be appointed by virtue of his or her knowledge and active involvement in the tourism industry.

Section 6 of the Act provides that no person shall be appointed to the board if such person-

- (a) Is not a citizen of the Republic;

- (b) at the relevant time is, or during the preceding 12 months was, a public servant other than a person appointed in terms of section 5(1) (e) , (f) , or (g), (being persons appointed by the responsible member to represent the three government departments) ;
- (c) at the relevant time is, or during the preceding 12 months was, a member of parliament, any provincial legislature or local authority, or any council, commission House of Traditional Leaders established in terms of the constitution;
- (d) at the time is, or during the preceding 12 months was, an office bearer or employee of any party, movement, organization or body of a party of a political nature;
- (e) has any direct or indirect interest in any gambling activity or any other business or enterprise that may conflict with the proper performance of his or her duties as a member of the board ; or his or her partner or associate, holds an office in or with, or is employed by, any person, company, organization, or other body, whether corporate or incorporated, which has an interest contemplated in paragraph (e);
- (f) is an unrehabilitated insolvent;
- (g) is of unsound mind, or is subject to an order of a competent court declaring such person to be mentally ill or disordered;
- (h) has at any time been convicted, whether in the Republic or elsewhere, of theft, fraud, forgery or uttering a forged document, perjury, an offence under this Act or

any Act providing for the prevention or criminalization of corruption or any offence involving dishonesty, and has been imprisonment without the option of a fine of to a fine not exceeding R500;

- (i) has at any time been removed from office of trust on account of misconduct;
- (j) is a family member, partner, or associate of a person contemplated in paragraph (b), (c), (d), (e) or (f);
- (k) failed to disclose an interest in terms of section 7 (2) (a), or attended participated in the proceedings of the board while having an interest contemplated in section 7 (1); and
- (l) is not a natural person.

Persons nominated must submit the following accompanying the nomination:

- (a) A letter of acceptance of nomination;
- (b) Proof of citizenship of the Republic of South Africa;
- (c) A sworn declaration that the person nominated is not disqualified in terms of section 6 of the Act; and
- (d) A full curriculum vitae.

Nominations must be received not later than 21 days from the date of publication hereof. No late nominations will be considered.


