#### CHANGE OF NAME FOR NDLUNKULU TRADITIONAL COUNCIL AS PROCLAIMED IN THE GOVERNMENT GAZETTE NO. 24 DATED 23 FEBRUARY 1973 TO BE DILATASHE TRADITIONAL COUNCIL

The name of Ndlunkulu Traditional Council as previously proclaimed in the Government Gazette shall be changed to Dilatashe Traditional Council in the district of Cofimvaba by the Royal Family.

The new name (Dilatashe) of the traditional council shall have administrative areas as previously proclaimed in the old name (Ndlunkulu).

Now, therefore, I, Sicelo Gqobana hereby make known the change of name of Ndlunkulu traditional council to Dilatashe traditional council with same administrative areas in the district of Cofimvaba as indicated on the attached Schedule.
