Whereas it is considered necessary in the interests of good administration to disestablish the Bhele Traditional Council as established at present, to re-establish Bhele Traditional Council with new jurisdictional areas and establish new traditional council called AmaBhele aseMbuthweni in respect of different administrative areas.

And whereas the tribes concerned and the Rarabe Regional Authority have been consulted and the Regional Authority has agreed to the proposed amended establishments;

Now, therefore, I, Sicelo Gqobana hereby make known that there shall be traditional council called Bhele and traditional council called AmaBhele aseMbuthweni in respect of the administrative areas in the district of Peddie indicated under their names in the Schedule hereto.

Government Notice No. 110 dated 26 October 1984 is hereby withdrawn in respect of the Bhele Traditional Council.
