Whereas it is considered necessary in the interests of good administration to disestablish the Khonjwayo Traditional Council as established at present, to re-establish Khonjwayo Traditional Council with new jurisdictional areas and establish new traditional council called Vulindlela in respect of different administrative areas.

And whereas the tribes concerned and the Nyandeni Regional Authority have been consulted and the Regional Authority has agreed to the proposed amended establishments;

Now, therefore, I, Sicelo Gqobana hereby make known that there shall be traditional council called Khonjwayo and traditional council called Vulindlela in respect of the administrative areas in the district of Ngqeleni indicated under their names in the Schedule hereto.

Government Notice No. 16 dated 14 May 1971 is hereby withdrawn in respect of the Khonjwayo Traditional Council.
