NOTICE OF LODGEMENT OF APPLICATION TO AMEND A RACE COURSE LICENCE

NOTICE IS HEREBY GIVEN that an application to amend a Race Course Licence in terms of section 35(1) of the Gambling and Betting Act, 1997 (Eastern Cape) (Act No. 5 of 1997) (as amended), particulars of which are set out in the Schedule hereunder, has been lodged with the Eastern Cape Gambling and Betting Board.

The applications may be inspected by any person at the offices of the of the Eastern Cape Gambling and Betting Board, ECGBB Building, Quenera Park, Quenera Drive, Beacon Bay, East London and Fairview Race Course, Draaifontein Road, Port Elizabeth.

Any objections, petitions or representations shall be lodged with the Chief Executive Officer of the Board within one month of the date of this notice.

All objections and comments shall specify: the application to which the objection or comment relates; the grounds on which the objection is founded; in the case of comment, full particulars and facts in substantiation thereof; the name, address, telephone and fax number of the objector or person making the comment and a statement whether the objector or person making the comment wishes to make oral representations when the application is heard.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.

(4) An application to amend the Licence Conditions imposed by the Board on Phumelela Gaming and Leisure Limited by the removal of the following conditions:

(a) The licensee shall pay a sum of R150 000.00 (one hundred and fifty thousand rand) annually to fund the Eastern Cape Amateur Horse Racing Association.

(b) The licensee shall pay R20 000.00 (twenty thousand rand) annually to assist the Eastern Cape Amateur Horse Racing Association's young riders attending training at the Thoroughbred Racing Development Centre in Elkenhof, Johannesburg for the period approximately 10 (ten) days.

(c) The Eastern Cape Gambling Board shall conduct a feasibility study on Traditional Horse Racing in the Eastern Cape. On completion of the feasibility study, the Licensee and the Eastern Cape Gambling Board shall agree on their respective roles in the introduction of the recommendations of the feasibility study on Traditional Horse Racing in the Eastern Cape.

(d) Notwithstanding the feasibility study, the licensee shall facilitate the introduction of Traditional Horse Racing in the Eastern Cape through:

- * Promoting Traditional Horse Racing through the media;
- * Hosting workshops on equine care, horse training and riding; and
- * Resuscitating the "work rider's programme" including the hosting of a sponsored race day.

(e) The licensee shall conduct and operate race courses to be situated on the sites as stipulated in annexure B and on those parts of those sites as stipulated in the application.

(f) The television signal fees charged by the licensee or its subsidiary for a licensed bookmaker to receive a television signal of any horseracing shall be determined by the licensee but shall be subject to the prior written approval of the ECGBB.

(g) The licensee shall for the duration of the licence continue to cross-subsidise and uphold the two racecourses at Arlington and Fairview, Port Elizabeth and continue to ensure that horseracing is held at those venues as provided for in the racecourse licence separately issued to the licensee.

(5) Fairview Race Course, Draaifontein Road and Arlington Race Course, Schoenmakerskop Road, Port Elizabeth.
