**NOTICE IN TERMS OF SECTION 15(1) OF THE UPGRADING OF LAND TENURE RIGHTS ACT, 1991
(ACT No. 112 OF 1991)**

I, **Mlibo Qoboshiyane**, being a Member of the Executive Council responsible for Local Government and Traditional Affairs, duly authorized thereto, hereby declare in terms of Section 15 (1) of Act No. 112 of 1991, that the township situated on Erf 30418, East London, on which the townships known as Duncan Village and Gompo are situated, be formalized townships for the purposes of Section 2 of Chapter 1 of the said Act.

The abovementioned townships have been approved in terms of the provisions of the Black Communities Development Act (Act No. 4 of 1984), and shall be registered in accordance with the provisions of Section 46 of the Deeds Registry Act, 1937 (Act 47 of 1937), with regard to the provisions of Act No. 4 of 1984, and in respect of which land tenure mentioned in Schedule 1 of Act No. 112 of 1991, have been granted.
