

**ACT NO 2 OF 2012 (EC) EASTERN CAPE GENERAL LAW AMENDMENT ACT, 2012****ACT**

**To repeal certain laws that are obsolete and to provide for matters connected therewith.**

**BE IT ENACTED** by the Legislature of the Province of the Eastern Cape, as follows:-

**REPEAL OF LAW**

1. The laws specified in the second column of the Schedule to this Act are hereby repealed to the extent indicated in the third column, in as far as they are applicable in, or have been assigned to the Eastern Cape Province.

**SHORT TITLE AND DATE OF COMMENCEMENT**

2. This Act is called the Eastern Cape General Law Amendment Act, 2012 and comes into operation on a date determined by the Premier by Proclamation in the Provincial Gazette.
