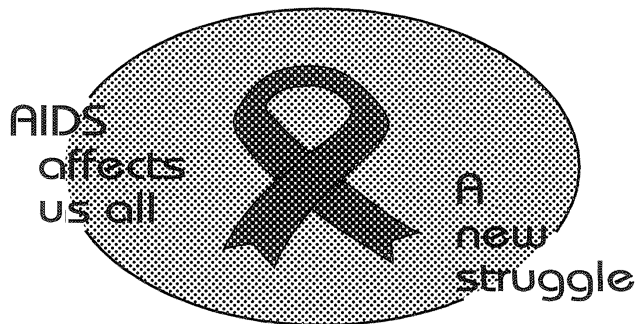

**APPROVED 2012 / 2013 ANNUAL BUDGET AND INTEGRATED DEVELOPMENT PLAN**

**AMENDMENT TO RATES AND TARIFFS**

**NOTICE IS HEREBY GIVEN** that the Senqu Municipal Council has in terms of section 24 of the Municipal Finance Management Act, No 56 of 2003, approved its Annual Operational and Capital Budget on the **31<sup>st</sup> of May 2012**. As required in terms of section 17 of the Municipal Finance Management Act, the Budget, Integrated Development Plan and Supporting Documents were tabled and advertised for representations / submissions by the local community, Provincial and National Treasury on the **30<sup>th</sup> March 2012** and **10<sup>th</sup> April 2012** respectively. All representations / submissions received before the **4<sup>th</sup> May 2012** were dealt with by council where after an operational budget of **R 144 207 330** and a capital budget of **R 45 153 750** were approved. Copies of the approved 2012 / 2013 Annual Budget and supporting documents are available at the Lady Grey, Barkly East and Sterkspruit administrative units of Senqu Municipality.

**Refuse Removal** tariffs would increase by **6.00%** as from the 1<sup>st</sup> July 2012.

**Electricity** tariffs would increase by **11.03%** once approved by the National Energy Regulator (NER).

Council would with effect 1<sup>st</sup> July 2012 apply the following differentiated **Assessment (Property) Rate Tariffs**:
