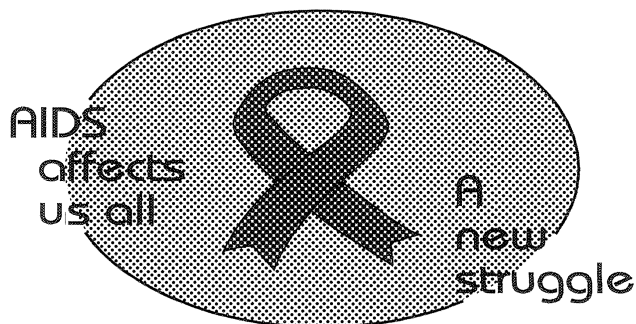

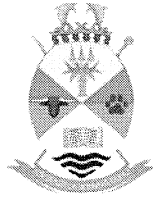

#### **NOTICE**

#### **BUDGET 2012/2013**

In terms of section 14(2) of the Local Government: Municipal Property Rates Act, 6 of 2004, the following resolution as adopted by council on **29 JUNE 2012** is hereby promulgated;

**"UNANIMOUSLY RESOLVED** that ;

1. the 2012/13 budget which was tabled by the Mayor for consideration in Accordance with Section 53 (c) of the Municipal Financial Management Act BE ADOPTED.
2. the budget linked to the Integrated Development Plan be approved.
3. all of the matters prescribed in Section 17 (1) (A-E); 17 (3) (a,b,c,d,e,f,j,k) of the Municipal Finance Management Act No. 56 of 2003 are included in the budget document and are approved.
4. the Budget Related Policies tabled, for the 2012/2013 financial year, with the amendments be approved.
5. the rates, water, refuse and sanitation increase of 9% for the financial year ending 30 June 2013 be approved.

6. the annual and monthly charges increase of 9% excluding electricity which will increase by 11.03% for the period 1 July 2012 to 30 June 2013 be approved.
7. the miscellaneous tariffs as set out in the budget document for the financial year 1 July 2012 to 30 June 2013 be approved.

**IT WAS THEREFORE MOVED THAT THE BUDGET BE UNANIMOUSLY ADOPTED AT 9% WHICH IS AN ASSESSMENT RATE OF 60 CENTS IN THE RAND.**
