

Notice is hereby given in terms of Section 49 (1)(a)(i) read in conjunction with Section 78 (2) of the Local Government: Municipal Property Rates Act, 2004, (Act 6 of 2004), hereinafter referred to as the "Act" that the 6th Supplementary Valuation Roll is open for public inspection.
