



Notice is hereby given, in terms of Section 6 and 14 of the Local Government Municipal Property Rates Act, of 2004 (Act No. 6 of 2004) (hereinafter referred to as the "Act"), to promulgate the resolutions passed for levying of rates and by-law in order to give the legal effect

The following resolutions as adopted by Council on 15 November 2011 is hereby promulgated :

UNANIMOUSLY RESOLVED that:

1. The approved commencing date of compiling the new general valuation to be 01 July 2011.

The following resolutions as adopted by Council on 29 June 2012 is hereby promulgated:

UNANIMOUSLY RESOLVED that:

- 1. The rates policy is approved for implementation in the 2012/13 financial year, which is the first year that the new general valuation is coming into effect.
- 2. The tariffs policy is approved for implementation in the 2012/13 financial year.

The approved property rates tariffs for 2012/13 for implementation are as follows:

Residential : R0.01433
Businesses : R0.01756
Government : R0.02107
Agricultural : R0.000275
