



GAMBLING AND BETTING ACT, 1997 (ACT NO 5 OF 1997) (EASTERN CAPE) (AS AMENDED) NOTICE OF LODGEMENT OF APPLICATIONS FOR BINGO LICENCES

Notice is hereby given that applications for Bingo Licences in terms of section 47 of the Gambling and Betting Act, 1997 (Eastern Cape) (Act No 5 of 1997) (as amended), the particulars of which are set out in the Schedules hereunder, have been lodged with the Eastern Cape Gambling and Betting Board. The applications may be inspected by any person at the offices of the Eastern Cape Gambling and Betting Board, ECGBB Building, Queenera Park, Queenera Drive, Beacon Bay, East London and at the respective municipalities within which the sites are located, as shown in the schedules below. Any objections, petitions or representations should be lodged with the Chief Executive Officer of the Board within one (1) month of the date of this notice, commencing on 18 December 2012 and ceasing on 17 January 2013.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.
