NOTICE OF LODGEMENT OF APPLICATIONS FOR

NOTICE IS HEREBY GIVEN that applications for Gambling Machine Site Licences in terms of section 50, read with section 49 (4) and a Bookmaker Licence in terms of section 53 of the Gambling and Betting Act, 1997 (Eastern Cape) (Act No. 5 of 1997) (as amended), particulars of which are set out in the Schedules hereunder, have been lodged with the Eastern Cape Gambling and Betting Board.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.
