It is hereby notified in terms of Section 33 of the Development Facilitation Act ,67 of 1995, that the Eastern Cape Tribunal has approved the land development area on Erven 10800 and 10804, Division of East London, Buffalo City Metropolitan Municipality – Case No DT (EC) 009/2010

The above approval includes the following :
