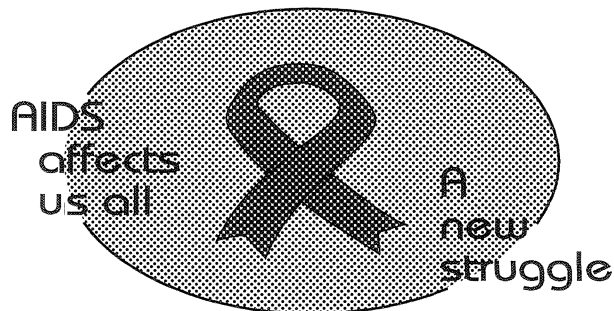

NOTICE OF LODGEMENT OF APPLICATIONS FOR GAMBLING MACHINE SITE LICENCES, ADDITION OF PREMISES AND BOOKMAKER LICENCE

Notice is hereby given that applications for gambling machine site licences and addition of premises in terms of sections 50 read with section 49(4), section 37 and section 53 of the Gambling and Betting Act, 1997 (Act No 5 of 1997) (Eastern Cape) (as amended), particulars of which are set out in the Schedules hereunder, have been lodged with the Eastern Cape Gambling and Betting Board.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.
