**PUBLICATION OF REGULATIONS MADE IN TERMS OF SECTION 80 OF THE
GAMBLING AND BETTING ACT (EASTERN CAPE), 1997 (Act No. 5 of 1997)**

I, **Mcebisi Jonas** Member of the Executive Council responsible for Economic Development, Environmental Affairs and Tourism in the Province of the Eastern Cape, acting in terms of section 80 of the Gambling and Betting Act (Eastern Cape), 1997 (Act No. 5 of 1997) and after consultation with the Eastern Cape Gambling and Betting Board, intend to make regulations as set out in the Schedule hereto.



SCHEDULE

1. Definitions

In these Regulations, any word or expression to which a meaning has been assigned in the Act shall have the same meaning, unless the context otherwise indicates —

"Regulations" means the Gambling and Betting Regulations, published under Provincial Notice No. 34 of 1998 in Provincial Gazette No. 338 of 25 September 1998; and

"the Act" means the Gambling and Betting Act, 1997, Act No. 5 of 1997 (Eastern Cape);

2. Amendment of regulation 43 of the Regulations

Regulation 43 of the Regulations is hereby amended —

(a) by the substitution in subregulation (1) for the words "cameras, monitors, videotape recorders and a video printer" of the words "cameras, monitors, videotape recorders or digital video recorders and a video printer or a device that can print digital images, as the case may be,";

(b) by the substitution in subregulation (2) for the word "videotape" of the words "videotape or digital video";

(c) by the substitution of subregulation (11) for the following subregulation:

"(11) The video printer or the device that prints digital images used in the surveillance system must possess the capability to generate instantaneously upon command, a clear, still black and white or colour copy or photograph of the images depicted on the videotape or digital video recording."; and

(d) by the substitution of subregulation (12) for the following subregulation:

"(12) The licensee must ensure that the surveillance system has the capability of creating first generation copies of video surveillance tapes or digital

surveillance recordings that are standard VHS format or new technology file system format, as the case may be, or any other format approved by the board.

3. Amendment of regulation 44 of the Regulations

Regulation 44 of the Regulations is hereby amended by the substitution of the words "video and audio tapes" for the words "video tapes or digital video recordings and audio tapes".

4. Amendment of regulation 47 of the Regulations

Regulation 47 of the Regulations is hereby amended by the insertion in subregulation (2) after the word "video" of the words "or digital media".

5. Amendment of regulation 49 of the Regulations

Regulation 49 of the Regulations is hereby amended —

- (a) by the insertion in subregulation (1) after the word "videotape" of the words "or digital video";
- (b) by the insertion in subregulation (2) after the word "video" of the words "or digital video";
- (c) by the insertion in subregulation (4) after the word "videotape" of the words "or digital video";
- (d) by the insertion in subregulation (5) after the word "videotape" of the words "or digital video";
- (e) by the insertion in subregulation (6) after the word "videotape" of the words "or digital video";
- and
- (f) by the insertion in subregulation (7) after the word "videotape" of the words "or digital video".

6. Amendment of regulation 52 of the Regulations

Regulation 52 of the Regulations is hereby amended by the substitution for the words "R5,00" of the words "an amount which may be determined by the Board.";

7. Amendment of regulation 53 of the Regulations

Regulation 53 of the Regulations is hereby amended by the substitution for the words "The return to players in any game of bingo shall not be less than 65% of the total amount staked by players on that game" of the words "A bingo game shall render a theoretical and demonstrable return to players of not less than 65 percent.";

8. Amendment of regulation 54 of the Regulations

Regulation 54 of the Regulations is hereby amended by the substitution for the words "All stakes and participation fees in respect of a bingo game shall be paid in cash" of the words "All stakes and fees in respect of bingo must be paid by either cash, token, ticket or other form of value, magnetic or smart card or any other method of payment prescribed by the MEC.";

9. Amendment of regulation 55 of the Regulations

Regulation 55 of the Regulations is hereby amended -by the insertion in subregulation

(2) after the word "recorders" of the words "or digital video recorders";

(a) by the substitution for subregulation (5) of the following subregulation:

"(5) The licensee must ensure that the surveillance system has the capability of creating first generation copies of video surveillance tapes or digital surveillance recordings that are standard VHS format or new technology file system format, as the case may be, or any other format approved by the board."

10. Amendment of regulation 62A of the Regulations

Regulation 62A of the Regulations is hereby amended —

(a) by the substitution for subregulation (1) of the following subregulation:

"(1) A limited gambling machine site licence which allows the licence holder to expose for play more than 5 limited gambling machines on such site shall only be awarded and issued if the number of limited gambling machines which shall be exposed for play on such site shall be no less than 6 but no more than 40.";

(b) by the deletion of subregulation (2).

11. Amendment of regulation 67 of the Regulations

Regulation 67 of the Regulations is hereby amended —

(a) by the insertion in subregulation (2) after the word "recorders" of the words "or digital video recorders";

(b) by the substitution for subregulation (4) of the following subregulation:

"(4) The licensee must ensure that the surveillance system has the capability of creating first generation copies of video surveillance tapes or digital surveillance recordings that are standard VHS format or new technology file system format, as the case may be, or any other format approved by the board."
