### ELECTORAL COMMISSION

**NOTICE IN TERMS OF SECTION 23 OF THE LOCAL GOVERNMENT:  
MUNICIPAL DEMARCATION ACT, 1998 READ WITH THE CONSTITUTION  
TWELFTH AMENDMENT ACT, 2005 AND THE CROSS-BOUNDARY  
MUNICIPALITIES LAWS REPEAL ACT, 2005.**

In term of section 23(2) of the Local Government: Municipal Demarcation Act, 1998, read with the Constitution Twelfth Amendment Act, 2005 and the Cross-Boundary Municipalities Laws Repeal Act, 2005, the Electoral Commission hereby expresses the view that the boundary re-determinations as determined by the Municipal Demarcation Board in terms of section 21(5)(c) of the Local Government: Municipal Demarcation Act of the municipalities referred to in Schedule 1 will affect the representation of voters in the councils of the municipalities. The boundary re-determinations of the municipalities referred to in the Schedule 2 will not materially affect the representation of voters in the councils of the municipalities.
