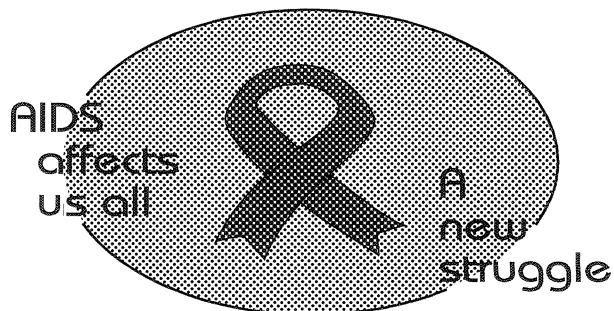

### PUBLIC NOTICE CALLING FOR INSPECTION OF THE FIRST SUPPLEMENTARY VALUATION ROLL (GENERAL VALUATION 2013) AND LODGING OF OBJECTIONS

Notice is hereby given in terms of Section 49 (1)(a)(i) read together with section 78(2) of the Local Government: Municipal Property Rates Act, 2004 ( Act No. 6 of 2004), hereinafter referred to as the "Act", that

the first supplementary valuation roll (GV 2013) for the financial years 01 July 2013 to 30 June 2014 is open for public inspection at the office of the Municipal Manager, 102 Main Street, Matatiele, Matatiele Library, Cedarville Office and Maluti Office during office hours 07:30 to 16:00 from 27 December 2013 to the 27<sup>th</sup> of January 2014.

An invitation is hereby made in terms of section 49(1)(a)(ii) read together with section 78(2) of the Act that any owner of property or other person who so desires may lodge an objection with the municipal manager in respect of any matter reflected in, or omitted from, the General Valuation Roll within the abovementioned period.

Attention is specifically drawn to the fact that in terms of section 50(2) of the Act an objection must be in relation to a specific individual property and not against the supplementary valuation roll as such.
