# GENERAL NOTICE

## GAMBLING AND BETTING ACT, 1997 (ACT NO 5 OF 1997) (EASTERN CAPE) (AS AMENDED)

### NOTICE OF LODGEMENT OF APPLICATIONS FOR ADDITION OF BOOKMAKER PREMISES, ACQUISITION OF FINANCIAL INTEREST AND GAMBLING MACHINE SITE LICENCES.

Notice is hereby given that applications for addition of bookmaker premises, acquisition of interest and gambling machine site licences in terms of section 37, section 40 and section 50, read with section 49(4) respectively, of the Gambling and Betting Act, 1997 (Act No 5 of 1997) (Eastern Cape) (as amended), particulars of which are set out in the Schedules hereunder, have been lodged with the Eastern Cape Gambling and Betting Board.
