# PROCLAMATION by the Premier of the Eastern Cape

# No. 3, 2014

DISSOLUTION OF THE EASTERN CAPE APPROPRIATE TECHNOLOGY UNIT (ECATU) IN TERMS OF THE CORPORATIONS ACT, 1985 (ACT NO.10 OF 1985) (TRANSKEI) READ TOGETHER WITH THE CORPORATIONS TRANSITIONAL PROVISIONS ACT, 1995 (ACT NO. 12 OF 1995) (EASTERN CAPE),

I, Noxolo Kiviet, Premier of the Province of the Eastern Cape, acting in terms of section 13 of Corporations Act, 1985 (Act No. 10 of 1985) (Transkei) as amended by section 19 of the Corporations Transitional Provisions Act (Eastern Cape), 1995 (Act No. 12 of 1995) hereby dissolve ECATU with effect from 30 April 2014 (the Dissolution Date).

The terms of the dissolution are as set out in the Schedule hereto.

### 3. Financial, administrative and other records of ECATU

All financial, administrative and other records of ECATU must be transferred to the Department.

#### 4. Employees of ECATU

(1) A person who, on the Effective Date, was in the employ of ECATU is transferred to the employ of the Department subject to terms and conditions contained in the Public Service Act, 1994 and the Department of Public Service and Administration's Guiding Principles for the <u>Disestablishment and</u> <u>Transfer of a Function from a Public Entity to a Department and the</u> <u>Concomitant Migration of Staff from the Public Entity to the Department</u> dated June 2011. SCHEDULE

#### 1. Legal Successor

- (1) As from 1 April 2014 (hereinafter referred to as "the Effective Date") the Department of Rural Development and Agrarian Reform ("the Department) is, for all purposes in law, the legal successor to ECATU, and
  - a. Becomes the owner of all movable and immovable property of ECATU;
  - b. Is substituted as contracting party for ECATU, in all contracts as if the Department had been the contracting party at the time of contracting and the contractual rights, obligations and liabilities of ECATU in terms thereof are transferred to the Department; and
  - c. Is deemed to have issued all financial instruments of ECATU.
- (2) Any money standing to the credit of ECATU in their bank accounts on the Effective Date vests in the Department and must be transferred to the bank account of the Department.
- (3) Any reference in any document to ECATU must be construed as a reference to the Department, unless such construction is clearly inappropriate.

#### 2. Legal Proceedings and internal proceedings and investigations

- (1) The dissolution of ECATU does not affect any civil matter pending for or against ECATU, and such matter must be continued and concluded with Department having substituted ECATU.
- (2) A civil matter is, for the purposes of this paragraph 2(1), deemed to be pending if, on the Effective Date, summons had been issued but judgment had not been given, and to be concluded when judgment is given.
- (3) Any internal hearing, investigation or disciplinary proceedings or process instituted by ECATU which is pending on the Effective Date, may be continued or instituted by the Department.
