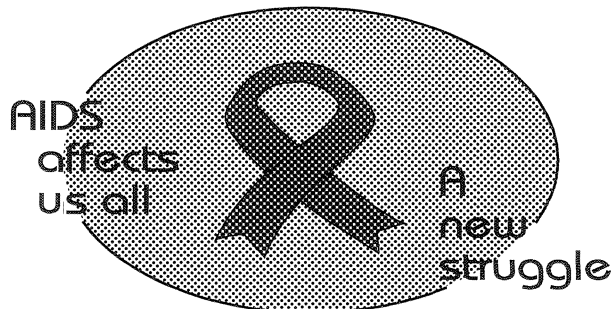

Notice is hereby given in terms of Section 49(1)(a)(i) read together with Section 78(2) of the Local Government : Municipal Property Rates Act, 2044 (Act 6 of 2004), hereinafter referred to as the "Act", that the Gariep Local Municipality's General Valuation roll for the period 1 July 2014 to 30 June 2018 will be open for public inspection at designated municipal venues from 1 April 2014 to 2 May 2014.

An invitation is hereby made in terms of Section 49(1)(a)(ii) read together with Section 78(2) of the Act that any owner of property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from the valuation roll within the above-mentioned period.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such. The form for lodging of an objection is obtainable from designated municipal venues or municipal website : www.gariep.gov.za .
