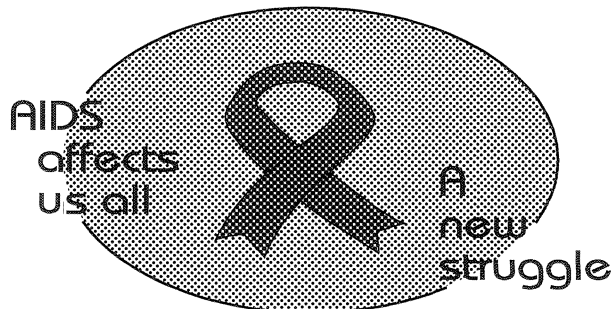

**PUBLIC NOTICE CALLING FOR INSPECTION OF VALUATION ROLL 2014/15 AND LODGING OF
OBJECTIONS**

Notice is hereby given in terms of Section 49(1)(a)(i) of the Local Government : Municipal Property Rates Act, 2004 (Act 6 of 2004), hereinafter referred to as the “Act”, that the Tsolwana Local Municipality’s Valuation roll 2014/15 will be open for public inspection at the Tarkastad municipal office and Hofmeyr municipal office from 3rd of February 2014 – 14th of March 2014. In addition the valuation roll is available at our website.

An invitation is hereby made in terms of Section 49(1)(a)(ii) of the Act that any owner of property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from the valuation roll within the above-mentioned period.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such. The form for lodging of an objection is obtainable from designated municipal venues. The completed forms must be returned to the Municipal Manager at the following address before or on the 14th of March 2014:
