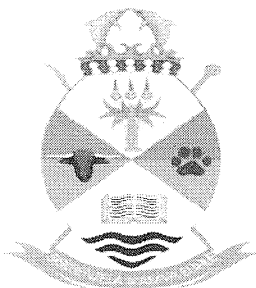

In terms of the Municipal Property Rates Act 2004, objections apply to a particular property and not to the Roll itself.

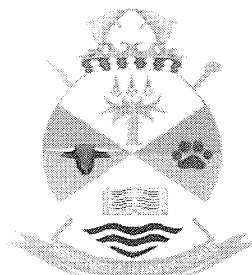
