APPROVED 2014 / 2015 ANNUAL BUDGET AND INTEGRATED DEVELOPMENT PLAN

AMENDMENT TO RATES AND TARIFFS

**NOTICE IS HEREBY GIVEN** that the Senqu Municipal Council has in terms of section 24 of the Municipal Finance Management Act, No 56 of 2003, approved its Annual Operational and Capital Budget on the **30<sup>th</sup> of May 2014**. As required in terms of section 17 of the Municipal Finance Management Act, the Budget, Integrated Development Plan and Supporting Documents were tabled and advertised for representations / submissions by the local community, Provincial and National Treasury on the **4<sup>th</sup> April 2014**. All representations / submissions received before the **5<sup>th</sup> of May 2014** were dealt with by council where after an operational budget of **R 189 580 240** and a capital budget of **R 56 206 100** were approved. Copies of the approved 2014 / 2015 Annual Budget, Integrated Development Plan and supporting documents are available at the Lady Grey and Barkly East administrative units of Senqu Municipality and the Sterkspruit Library.

**Refuse Removal** tariffs would increase by **6.00%** as from the 1<sup>st</sup> July 2014.

**Electricity** tariffs would increase by **7.39%** once approved by the National Energy Regulator (NER).

Council would with effect 1<sup>st</sup> July 2014 apply the following differentiated **Assessment (Property) Rate Tariffs**:
