



NOTIFICATION OF RESULTS OBJECTIONS AGAINST GENERAL PROPERTY VALUATION ROLL

Notice is hereby given that the results of objections lodged against the General Property Valuation Roll are available for inspection.

Rolls will be available at Human Settlements and Land Development Directorate situated at 2c Komani Street, Queenstown (Opposite Nonesi Mall). Electronic rolls will be made available on www.lukhanji.co.za and at the Queenstown Library.

An Objector has the right in terms of Section 54(1) a right to Appeal against the decision of the Valuer. An objector must lodge and appeal within 30 days after 30 September 2014 if he does wish to ask for reasons as set out in terms of Sec 53(2). In terms of Sec 53(2) the objector may, within 30 days of notices (30 September 2014), ask for the furnishing of reasons for the decision of the Valuer. The Valuer has in terms of Sec 53(3) 30 days after the request for reason, time to furnish such reasons. In terms of Sec 54(2)(a) the Objector, if needed, has 21 days after receiving the 'reasons' time to lodge an appeal.
