### DECLARATION OF STATE OF LOCAL DISASTER

On the 11<sup>th</sup> October 2014 a Tornado hit four (4) of the Chris Hani local Municipalities, leaving a number of destitute families homeless; schools and infrastructure damaged in some areas; especially electricity which electrocuted a child in Lukhanji, Mbekweni village. The damages had been assessed and costed.

The Chris Hani District Municipality hereby declare a state of disaster in terms of Section 55 of the Disaster Management Act, 57 of 2002 as a result of the abovementioned incident. The damages are as follows:
