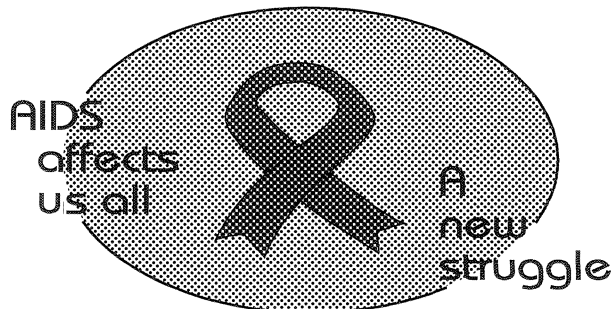

## GENERAL NOTICE

No. 47

### GAMBLING AND BETTING ACT, 1997 (ACT NO 5 OF 1997) (EASTERN CAPE) (AS AMENDED)

#### Notice of Lodgement of Applications for Gambling Machine Site Licences, Removal of Business to other Premises and Addition of Bookmaker Premises

Notice is hereby given that applications for gambling machine site licences, removal of business to other premises and addition of bookmaker premises, in terms of sections 50, read with section 49, 37 and 53 respectively, of the Gambling and Betting Act, 1997 (Act No 5 of 1997) (Eastern Cape) (as amended), particulars of which are set out in the Schedules hereunder, have been lodged with the Eastern Cape Gambling and Betting Board.

Any objections, petitions or representations should be lodged with the Chief Executive Officer of the Board within one (1) month of the date of this notice, commencing on 8 April 2015 until 7 May 2015.

All objections and comments should specify: The application to which the objection or comment relates; the grounds on which the objection is founded; and in the case of comment, full particulars or facts in substantiation thereof: The name, address, telephone and fax number of the objector or person making the comment and a statement whether the objector or person making the comment wishes to make oral representations when the application is heard.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.

The under-mentioned figures used in brackets in Schedules have the following meanings:
