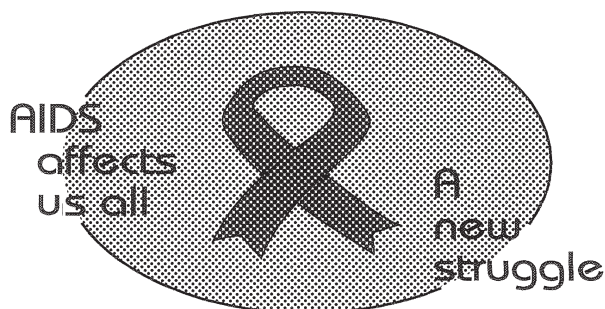

**(BY THE MEMBER OF THE EXECUTIVE COUNCIL RESPONSIBLE FOR
CO-OPERATIVE GOVERNANCE AND TRADITIONAL AFFAIRS IN THE
PROVINCE OF THE EASTERN CAPE)**

BILL

To repeal obsolete and old order legislation dealing with local government and traditional affairs in the Province of the Eastern Cape; and to provide for matters connected therewith.

BE IT ENACTED by the Legislature of the Province of the Eastern Cape, as follows:-

REPEAL OF LAWS

1. The laws mentioned in the second column of the Schedule are hereby repealed to the extent set out in the third column thereof.

SHORT TITLE

2. This Act is called the Repeal of Local Government and Traditional Affairs Laws Act (Eastern Cape), 2015 and shall come into operation on a date determined by the premier by proclamation in the Provincial Gazette.

EXPLANATORY MEMORANDUM ON THE REPEAL OF LOCAL GOVERNMENT AND TRADITIONAL AFFAIRS LAWS (EASTERN CAPE) BILL, 2015

PART 1

(GENERAL PRINCIPLES)

BACKGROUND

The Province inherited a myriad of laws from the then Cape Provincial Administration, Republics of Transkei and Ciskei. Some of these laws have become obsolete and therefore it is necessary that they be removed from the statute books. This Bill is therefore intended to repeal all these obsolete laws.

REASONS AND EFFECT OF THE BILL

The Bill is to ensure that old order legislation is repealed thereby creating legal certainty.

OBJECTS OF THE BILL

The objects of the Bill is to repeal obsolete and old order legislation of the Eastern Cape Province.
