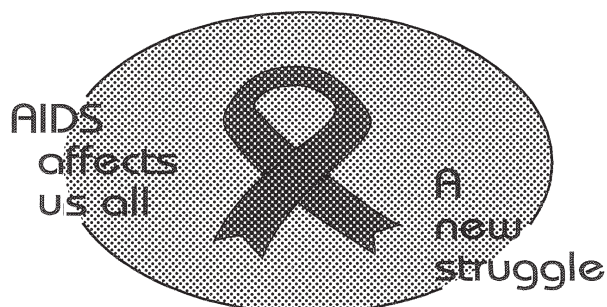

With effect from **01 October**, GPW will not longer accept amendments to notices. The cancellation process will need to be followed and a new notice submitted thereafter for the next available publication date.

Until then, amendments to notices must be received before the submission deadline.

When submitting your notice request to [submit.egazette@gpw.gov.za](mailto:submit.egazette@gpw.gov.za), please ensure that a purchase order (GPW Account customer) or proof of payment (non-GPW Account customer) is included with your notice submission. All documentation relating to the notice submission must be in a single email.

A reminder that documents must be attached separately in your email to GPW. (In other words, your email should have an Adobe Form plus proof of payment/purchase order – 2 separate attachments – where notice content is applicable, it should also be a 3rd separate attachment).

PROPOSED RECLASSIFICATION OF A PORTION OF DR02792 TO A MINOR ROAD STATUS AND  
DEPROCLAMATION OF A PORTION OF MINOR ROAD 31 KOMGA DIVISION

In terms of Section 17 of the Eastern Cape Roads Act (Act 3/2003) a notice is hereby given to invite public opinion, comments and/or objections from all interested parties for the following linked application received:

- To reclassify a portion of DR02792 from a district road to a minor road. This portion being from the location of "Gate1" at the entrance to the Tyityaba Game Reserve on Farm 237 to "Gate 2" the boundary of Farm 235 and Farm Glen Kei (farm 234) a distance of approximately 10.2 km.
- To deproclaim a portion of Minor Road from " Gate 3" at the boundary of Farm Glen Kei and Farm 233 portion 1 to the end point of the proclaimed minor road on the boundary of Farm 233 Portion 1 and Farm 233 Portion 2, a distance of approximately 1.0 km.

The motivation for the reclassification of a portion of DR02792 are as follows;

1. DR02792 (old Divisional Road 107/original Divisional Road 32)as proclaimed in 1935 starts at the N2 and ends at the common boundary of Farm 235 and 234(Glen Kei)
2. Farms 237, 236 and 235 served by the end portion of DR02792 have been amalgamated into the Tyityaba game reserve. The end portion of DR02792 therefore now only carries very limited traffic consisting of occasional traffic for the Tyityaba reserve purposes as well as daily traffic for Farm 234 (Glen Kei).
3. The function of the road has therefore changed from a district road to that of a minor road.
4. The reclassification will allow the legal erection/existence of gates and the absence of fences along the section of road to suit the land use of the amalgamated farm (i.e. game reserve) while retaining public access along the road as similarly already allowed along minor road 31.
5. Due to the walking distance from the Glen Kei farmstead to the nearest farmsteads outside of the Tyityaba reserve (min. of approx. 20 km one way) or to or from public transport routes (approx. 27km one way) there is no regular pedestrian movement along this section of road.
6. The applicant will comply with any terms for the operation of any gates, maintenance of vegetation control for public roads through game reserves and accommodation of any occasional pedestrian which will be applied by the applicable authorities.

The motivation for the deproclamation of a portion of Minor road 31are as follows:

7. Minor Road 31 was proclaimed in 1964 and continues from the end point of DR02792 across Glen Kei farm in an easterly direction, crossing onto Farm 233 Portion 1 and terminating at the common boundary of portion 1 and Portion 2 of farm 233 so as to ensure public access to all these mentioned farms.
8. Portion 1 and 2 of farm 233 have both been incorporated into the Tyityaba reserve and therefore portion 2 does not require independent access.

9. This final section of road is not in use and has overgrown
10. The deproclamation of the final section of Minor road 31 will allow the gate at the boundary of Farm 234 and farm 233 Portion 2 which will become the new end point of the minor road to be locked for game security purposes

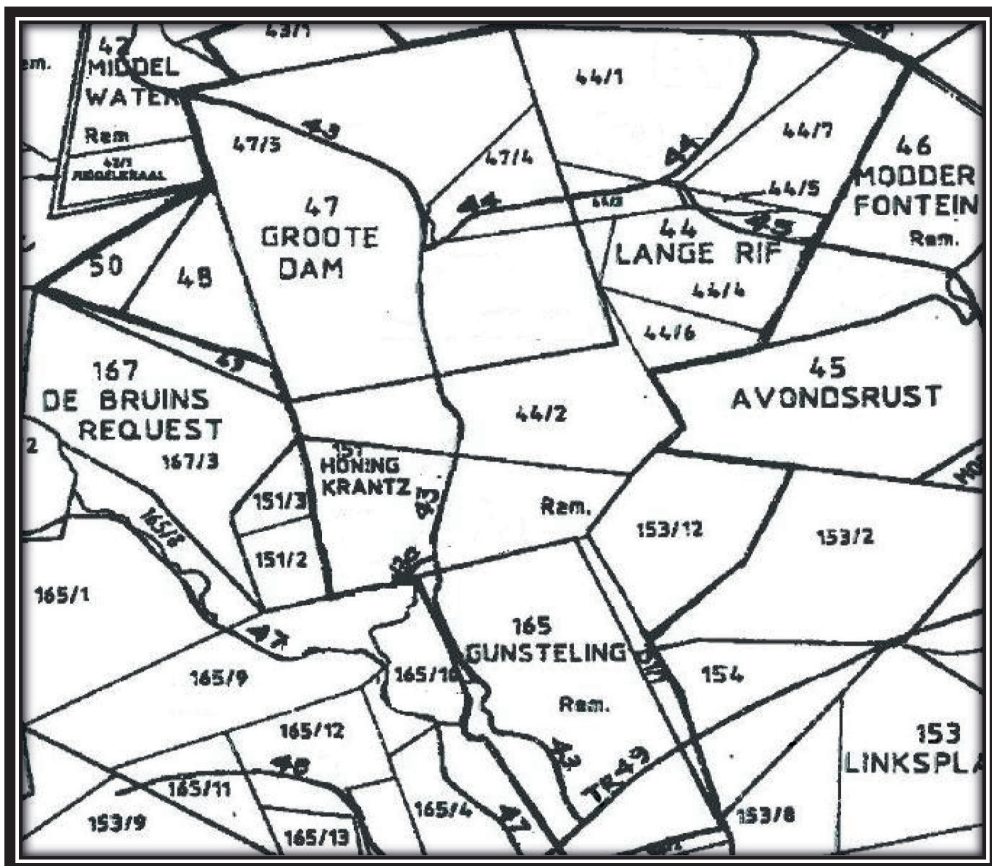

PROPOSED DEPROCLAMATION OF A OF MINOR ROADS 44 AND 130 AND PORTIONS OF MINOR ROADS 43 AND 45, CRADDOCK DISTRICT

In terms of Section 17 of the Eastern Cape Roads Act (Act 3/2003) a notice is hereby given to invite public opinion, comments and/or objections from all interested parties for the following linked application received:

- To deproclaim a portion of Minor Road 43c (also known as MN40053 and MN40150) running from the R61 (TR00049) on the Farm Gunsteling running in a northerly direction across the farms Heuningkrans and Gootdam to the border of farm Middelwater .
- To deproclaim Minor road 44c (also known as MN40155) running from the intersection with Minor road 43 on Farm Grootdam in a North Easterly direction across Grootdam and farm Lange Rif to the border of farm Grootvlakte.
- To deproclaim a portion of Minor Road 45 from its intersection with Minor Road 44 on the farm Lange Rif and running in a South Easterly direction to the border of farm Modderfontein
- To deproclaim Minor Road 130c from its intersection with Minor road 43 on farm Heuningkrans running in a South Westerly direction to the border of Farm Modderpoort





The motivation for the deproclamation of all roads are as follows:

1. Minor Roads 43,44 and 45 were proclaimed in in 1958 and Minor Road 130c in 1979 to provide access to and across various Farms in the Craddock District. As the Farms Grootdam, Grootvlakte, LangeRif, Heunigkrans and Gunstelling are now all owned by one owner and all neighbouring farms have access via alternate Minor Roads or directly from the R61 the need for public access along these Minor roads no longer exists.
2. The deproclamation of the Minor roads will allow access along the roads to be controlled for farm security and stock theft reasons
3. Emergency access to neighboring farms along the deproclaimed roads will be upheld.

This means that any notice submissions not on an Adobe electronic form that are submitted to this mailbox will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be **rejected**. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
6. The current cut-off of all Gazette's remains unchanged for all channels. (Refer to the GPW website for submission deadlines – [www.gpwonline.co.za](http://www.gpwonline.co.za))
7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. Assistance will be available through the Contact Centre should help be required when completing the forms. (012-748 6200 or email [info.egazette@gpw.gov.za](mailto:info.egazette@gpw.gov.za))
8. All re-submissions by customers will be subject to the above cut-off times.
9. All submissions and re-submissions that miss the cut-off will be rejected to the customer to be submitted with a new publication date.
10. Information on forms will be taken as the primary source of the notice to be published. Any instructions that are on the email body or covering letter that contradicts the notice form content will be ignored.

You are therefore advised that effective from **Monday, 18 May 2015** should you not comply with our new rules of engagement, all notice requests will be rejected by our new system.
