Government Printing Works has over the last few months implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submit your notice request.

In line with these business rules, GPW has revised the notice submission deadlines for all gazettes. Please refer to the GPW website www.gpwonline.co.za to familiarise yourself with the new deadlines.

CANCELLATIONS

Don't forget!

Cancellation of notice submissions are accepted by GPW according to the deadlines stated in the table above.

Non-compliance to these deadlines will result in your request being failed. **Please pay special attention to the different deadlines for each gazette.**

Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.

Requests for cancellation must be sent by the original sender of the notice and must accompanied by the relevant notice reference number (N-) in the email body.

AMENDMENTS TO NOTICES

take note!

With effect **from 01 October**, GPW will not longer accept amendments to notices. The cancellation process will need to be followed and a new notice submitted thereafter for the next available publication date.

CUSTOMER INQUIRIES



Many of our customers request immediate feedback/confirmation of notice placement in the gazette from our Contact Centre once they have submitted their notice – While GPW deems it one of their highest priorities and responsibilities to provide customers with this requested feedback and the best service at all times, we are only able to do so once we have started processing your notice submission.

PROOF OF PAYMENTS



GPW reminds you that all notice submissions **MUST** be submitted with an accompanying proof of payment (PoP) or purchase order (PO). If any PoP's or PO's are received without a notice submission, it will be failed and your notice will not be processed.

When submitting your notice request to submit.egazette@gpw.gov.za, please ensure that a purchase order (GPW Account customer) or proof of payment (non-GPW Account customer) is included with your notice submission. All documentation relating to the notice submission must be in a single email.

A reminder that documents must be attached separately in your email to GPW. (In other words, your email should have an Adobe Form plus proof of payment/purchase order – 2 separate attachments – where notice content is applicable, it should also be a 3rd separate attachment).

REMINDER OF THE GPW BUSINESS RULES

- ☐ Single notice, single email – with proof of payment or purchase order.
- ☐ All documents must be attached separately in your email to GPW.
- ☐ 1 notice = 1 form, i.e. each notice must be on a separate form
- ☐ Please submit your notice **ONLY ONCE**.
- ☐ Requests for information, quotations and inquiries must be sent to the Contact Centre **ONLY**.
- ☐ The notice information that you send us on the form is what we publish. Please do not put any instructions in the email body.

By virtue of the powers vested in me by the Eastern Cape Legislature and in terms of the Eastern Cape Gambling and Betting Board Act No 5 of 1997 ("the Act"), I hereby notify that I have appointed the following persons as non-executive members of the Eastern Cape Gambling and Betting Board for a period of five years, with effect from 01 April 2016 to 31 March 2021:

1	Adv. Ncumisa Mayosi	5 Years	5(1)(a) – One member shall be qualified to be admitted to practice as a legal practitioner in the Republic and has, for a cumulative period of at least 5 years after having so qualified, practised as a legal practitioner or performed service related to the application of administration of law
2	Mr. Odwa Mtati	5 Years	5(1)(d) – One member shall be appointed by reason of his or her knowledge and experience in the field of welfare or of community or socio-economic development
3	Mr. Mzwandile Vena	5 Years	5(1)(h) - One member shall be appointed to represent the interests of the community at large
4	Mr. Pierre Voges	5 Years	5(1)(c) – One member shall be appointed by virtue of his or her knowledge and active involvement in the tourism industry
5	Mr. Phillip White	5 Years	5(1)(b) - One member shall be qualified as a chartered accountant in the Republic, who has been so qualified for a period of at least 5 years, and, for a cumulative period of at least 5 years after having so qualified, has practised as a chartered accountant
6	Ms. Nonkqubela Mlenzana	5 Years	5(1)(g) – One member shall represent the Department of Safety and Security, designated by the Member of the Executive Council responsible for that Department
7	Ms. Vanessa Fredericks	5 Years	5(1)(f) – One member shall represent the Department of Finance, Provincial Expenditure and Management Services of the Province, designated by the Member of the Executive Council responsible for that Department
8	Mr. Albert Mfenyana	5 Years	5(1)(e) – One member shall represent the Department of Economic Affairs, Environment and Tourism of the Province, designated by the Member of the Executive Council responsible for that Department

Pursuant to the same section of the Act mentioned above, I have appointed Adv. Ncumisa Mayosi as Chairperson and Mr. Odwa Mtati as the Deputy Chairperson of the Board, respectively, with effect from 01 April 2016 to 31 March 2021.
