INTENTION TO DECLARE NATURE RESERVES**

I, Sakhumzi Somyo, Member of the Executive Council (MEC) for Economic Development, Environmental Affairs and Tourism, hereby give notice in terms of section 33(1)(a) of the National Environmental Management: Protected Areas Act, 2003 (Act 57 of 2003), of my intention to:

- a) declare nature reserves, under section 23 (1) (a) (i) of the said Act, on the properties as indicated in the attached schedule;
- b) declare an area as part of an existing nature reserve, under section 23 (1) (a) (ii) of the said Act, on the properties as indicated in the attached schedule;
- c) assign names to the nature reserves, under section 23 (1) (b) of the said Act, as indicated in the attached schedule;
- d) assign the management of the nature reserves to a suitable organisation, under section 38 (2) (a) of the said Act, as indicated in the attached schedule.
