### **PART 3 [MBHASHE LOCAL MUNICIPALITY]**

#### **Replacement of item 3 of Part 3 of the schedule**

Item 3 of Part 3 of the Schedule is replaced as follows-

The local municipality is of a type as described in Section 3(d) of the Determination of Type of municipality Act, 2000, (Act 5 of 2000 EC) [a municipality with a mayoral executive system combined with ward participatory system]

#### **Replacement of item 7 of Part 3 of the Schedule**

Item 7 of Part 3 of the Schedule is replaced as follows-

The council of the local municipality may, subject to the conditions contained in paragraph 6(2) in this Part, designate any of the following office-bearers as full-time-

- (a) Executive Mayor
- (b) Speaker
- (c) A member of the Mayoral Committee
- (d) Chief Whip
- (e) Chairperson of a Committee established in terms of Section 79
