ADOPTED 2017/ 2018 ANNUAL BUDGET AND 2017-2022 INTEGRATED DEVELOPMENT PLAN, RATES AND TARIFFS

Notice is hereby given that the Senqu Municipal Council has in terms of section 24 of the Municipal Finance Management Act, No 56 of 2003, approved its Annual Operational and Capital Budget and its Integrated Development Plan 2017-2022 in terms of Chapter 5 of the Municipal Systems Act 32 of 2000 on the 30th of May 2017. As required in terms of section 17 of the Municipal Finance Management Act, the Budget, Integrated Development Plan and Supporting Documents were tabled and advertised for representations / submissions by the local community, Provincial and National Treasury on the 4th of April 2017. All representations / submissions received before the 8th of May 2017 were dealt with by Council where-after an operational budget of R 220 144 948 and a capital budget of R 79 627 461 was approved. Copies of the approved 2017 / 2018 Annual Budget, 2017 -2022 Integrated Development Plan and supporting documents are available at the Lady Grey administrative unit, Barkly East administrative unit, the Sterkspruit administrative unit and the local libraries.

Refuse Removal tariffs will increase by 6.00% as from the 1st July 2017.

Electricity tariffs would increase by 1.88 % from 1 July 2017.

Council will, with effect from the 1st July 2017 apply the following differentiated Assessment (Property) Rate Tariffs: with a 6% overall increase.
