**EXTRA-ORDINARY PROVINCIAL NOTICE****PROVINCE OF THE EASTERN CAPE****KOUGA LOCAL MUNICIPALITY (EC108)****NOTICE 92/2017****DECLARATION OF A LOCAL STATE OF DISASTER IN THE KOUGA MUNICIPAL AREA DUE TO PREVAILING DROUGHT CONDITIONS**

NOTICE IS HEREBY GIVEN that, in terms of Section 55(1) of the Disaster Management Act (Act 57 of 2002), the Kouga Municipality, Eastern Cape, intends to declare the Kouga Municipal Area of Jurisdiction, a Local State of Disaster, due to prevailing drought conditions.

At an Ordinary Council Meeting held on 31 May 2017 an item on the abovementioned matter was tabled, whereby the Council resolved as follows:

- i) That Council, in terms of Section 55(1) of the Disaster Management Act No 57 of 2002, declare a local state of disaster.
- ii) That Administration arrange for the gazetting of said declaration in the Provincial Gazette.
- iii) That a schedule of Council resources, personnel and funds be allocated for the implementation of water conservation and demand management initiatives, to reduce water usage.
- iv) That the Infrastructure Planning and Development Directorate develops an Emergency Action Plan for implementation.
- v) That application be made to Provincial and National Government for additional funds to assist Kouga Municipality with the implementation of emergency measures.
- vi) That **PART C** of the approved Schedule of Water Charges and Tariff Structure be implemented with immediate effect.
