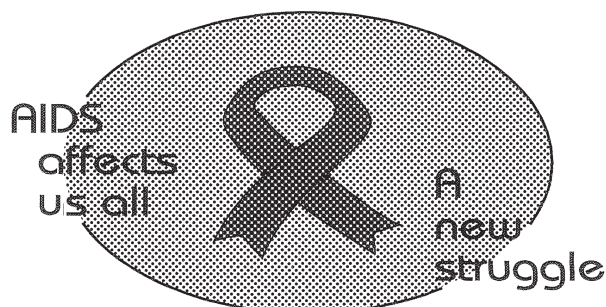

LOCAL AUTHORITY NOTICE 147 OF 2017**KOUGA LOCAL MUNICIPALITY (EC108)****NOTICE 155/2017****DECLARATION OF A LOCAL STATE OF DISASTER IN THE KOUGA MUNICIPAL AREA DUE TO
WIDESPREAD VELDTS FIRES - EXTENSION OF TIME**

NOTICE IS HEREBY GIVEN that, in terms of Section 55(1) of the Disaster Management Act (Act 57 of 2002), the Kouga Municipality, Eastern Cape, intends to extend the declaration period that declares the Kouga Municipal Area of Jurisdiction, a Local State of Disaster, due to widespread damages caused by veldt fires from 7 – 11 June 2017, with a period of one (1) month – up to 13 October 2017.

At a Special Council Meeting held on 8 September 2017 an item on the abovementioned matter was tabled, whereby the Council resolved as follows:

- i) That the Council, in terms of Section 55(5)(C) of the Disaster Management Act. No 57 of 2002, extend the Local State of Disaster period by one month, to end on 13 October 2017.
- ii) That the necessary Notice be placed in the Provincial Government Gazette.
- iii) That the Sarah Baartman District Municipality be notified of the 1 month extension to the disaster period.
- iv) That delegated authority be given to the Executive Mayor for further extensions, if required.
