The draft Site Licence RFP may be amended by the Board after consideration of the aforesaid written submissions and may culminate in the issue of a final RFP.

Please note that the final Site Licence RFP will constitute the basis of any evaluation for any proposal for the Gambling Machine Site Licence and not the Draft Site Licence RFP. The Draft Site Licence RFP may substantially change in format and content when it reaches the final Site Licence RFP stage and no liability for any change, damage or loss that may be incurred by any person as a result of this shall accrue/lie to the Board. Purchase of the Final Site Licence RFP will be compulsory in respect of each application to be submitted.
