Notice is hereby given in terms of section 49(1) (a)(i)(ii) read together with section 78 (2) of the Local Government: Municipal Property Rates Act, 2004 (Act No.6 of 2004) as amended, herein after referred to as the "Act", that the General Valuation Roll effective for the period of 01 July 2020 to 30 June 2025 will be open for public inspection in the designated Municipal offices situated in Dutywa, Willowvale and Elliotdale and on the municipal website [www.mbhashemun.gov.za](http://www.mbhashemun.gov.za). Attention is specifically drawn to the fact that in terms of section 50(2) of the Act, an objection must be in relation to a specific individual property and not against the Valuation Roll.

Completed prescribed objection forms must be returned to the address as indicated below **before 15:00 on the closing date of 31<sup>st</sup> March 2020**, please note that objections lodged after the closing date will not be considered.
