## DRAFT REQUEST FOR PROPOSAL FOR GAMBLING MACHINE SITE LICENCES

Notice is hereby given that the Draft Request for Proposal for gambling machine site licences ("the Draft Site Licence RFP") in the Eastern Cape will be available from **Monday, 30 November 2020** from the Eastern Cape Gambling Board website ([www.ecgb.org.za](http://www.ecgb.org.za)) downloadable at no cost.

The purpose of the Draft Site Licence RFP is to invite written comments and suggestions from all interested parties and potential bidders, to highlight the requirements of the RFP, to draw attention to the Essential Minimum Requirements ("EMR's"), to explain the consequences of non-compliance and to explain the evaluation process. The draft site licence RFP may be amended by the Board after consideration of the aforesaid written submissions and may culminate in the issue of a final site licence RFP.

Please note that the final site licence RFP will constitute the basis of any evaluation for any proposal for the gambling machine site licence and not the Draft site licence RFP. The Draft site licence RFP may substantially change in format and content when it reaches the final site licence RFP stage and no liability for any change, damage or loss that may be incurred by any person as a result of this shall accrue/lie to the Board. Purchase of the Final RFP will be compulsory in respect of each application to be submitted.
