NOTICE OF LODGEMENT OF VARIOUS APPLICATIONS FOR TRANSFER OF LICENCE TO ANOTHER PERSON, REMOVAL OF BUSINESS TO OTHER PREMISES AND ACQUISITION OF FINANCIAL INTEREST IN TERMS OF THE EASTERN CAPE GAMBLING ACT, 1997 ("the Act").

NOTICE IS HEREBY GIVEN that applications for transfer of licence to another person, removal of business to other premises and acquisition of financial interest in terms of sections 36, 37 and 40 of the Act, particulars of which are set out in the schedules hereunder, have been lodged with the Eastern Cape Gambling Board.

All objections and comments shall specify: the application to which the objection or comment relates; the grounds on which the objection is founded; in the case of comment; full particulars or facts in substantiation thereof: the name, address, telephone and fax number of the objector or person making the comment and a statement whether the objector or person making the comment wishes to make oral representations when the application is heard.

A person lodging representations may show cause why the Board may determine that his or her identity should not be divulged.

The under-mentioned figures used in brackets in Schedules have the following meanings:
