(ACT NO. 10 OF 2003)****MITIGATION OF LOSS SUFFERED BY LIQUOR LICENCEES: EXTENSION OF VALIDITY OF
REGISTERED LICENCES AND DEFERRAL OF FEES PAYABLE**

I, **Mlungisi Gerald Mvoko**, member of the Executive Council responsible for Economic Development, Environmental Affairs and Tourism in the Province of the Eastern Cape in concurrence with the Member of the Executive Council responsible for Finance in the Province of the Eastern Cape, acting in terms of section 69(1)(b) of the Eastern Cape Liquor Act, 2003 (Act No.10 of 2003) hereby publish a notice in respect of the Regulations.

In terms of Section 69(1)(b) a notice was published in the Provincial Gazette 4463 (Extraordinary) on 23 October 2020 allowing for the period for renewal of licences to be extended to 30 June 2021.

Considering the ongoing CoVid-19 pandemic and the financial constraints it has placed on the liquor industry, it has necessitated further relief to licence holders.

I therefore pronounce the following:

1. Retrospective condonement of the non-payment, late payment or partial payment of renewal fees which were due to be fully paid by 30 June 2021.
2. Full payment of renewal fees is hereby extended to 31 December 2021;

3. Failure to effect full payment of renewal fees by 31 December 2021 will result in the cancellation of the licence
4. The period for the payment of renewal fees of licences for the 2022 year is hereby extended and will commence on 1 October 2021 and end on 30 June 2022;
5. Payment of penalty fees for the above periods as well as late payment, non payment and partial payment is hereby waived.

This Notice is called the Extension of Mitigation of loss suffered by licencees due to CoVID-19 and comes into operation on the date of publication in the Provincial Gazette.

This notice will allow for relief suffered by licence holders due to the restrictions placed on the liquor industry as set out in the Regulations to the Disaster Management Act, 2002 as a response to the CoVID-19 outbreak.
