Whenever the word stock inspector appears in these by-laws be changed to read as 'animal health technician'.

#### DEFINITIONS

"health officer" means a person authorized in terms of the relevant legislation.

**ANIMALS DYING IN THE POUND**

The Carcass of any animal which dies in the Pound or that suffers from any contagious disease shall be disposed of as directed by the Veterinary Surgeon or Health Officer and the owners of such animals, if known, shall pay all cost in connection therewith.

**INSPECTION OF AND EXTRACTS FROM POUND REGISTER**

Every pound register shall be kept at the pound or any other approved place and shall at all reasonable times be open for inspection, free of charge, to any authorized officer of the municipality, veterinary surgeon, animal health technician, health officer and any member of the South African Police Service and any member of the public.

**FEES PAYABLE**

15 [2] No pound master shall release any impounded animal until the prescribed fees and charges or tariffs have been paid to the municipality and written proof thereof submitted to the pound master.
