Any person who desires to object to the new tariffs being implemented shall do so in writing, within 14 days from the date of this notice being published in the press, to the Municipal Manager, PO Box 20, Zastron 9950.

All moneys due to the Council will be payable on the first day of the month follow the month of consumption and usage, failing which, interest may be levied on rates at a rate one percent higher than the rate payable by the Council to its bank in respect of an overdraft, for the period during which such amounts remain unpaid.
