PROCLAMATION

[No. 56 of 2007]

HUNTING SEASON: 2008

By virtue of the powers vested in me by section 4 of the Nature Conservation Ordinance, 1969 (Ordinance No. 8 of 1969), I hereby declare that any person may hunt ordinary game as follows:

Free State Province Hunting Season for the Year 2008	
Species of ordinary game in accordance with Schedule 2	Period during which hunting may take place and bag limits for terrestrial game birds and waterfowl
<p>Helmeted Guineafowl, Swainson's Francolin [Swainson's Spurfowl] Grey-winged Francolin, Orange River Francolin and Common Quail. Egyptian Goose, Spur-winged Goose, Yellow-billed Duck, Red-billed Teal and Red-knobbed Coot.</p> <p>Birds not mentioned above are listed as protected species in accordance with schedule 1 of Ordinance 8 of 1969.</p>	<p>1st May 2008 up to and including 31st August 2008.</p> <p>A maximum of ten (10) terrestrial gamebirds, and ten (10) waterfowl per hunter per day (including wounded birds and those not retrieved). Any Ordinary gamebird, except for Common Quail, may be hunted if in groups of three or more birds (pairs and single birds may be breeding).</p>
<p>Bontebok, Blesbok, Blue Wildebeest, Bushbuck, Gemsbuck, Giraffe, Red Hartebeest, Impala, Common Reedbuck, Burchell Zebra, Hartmann Zebra, Waterbuck, African Buffalo, Springbuck, Black Wildebeest, Kudu and Eland.</p>	<p>1st May 2008 up to and including 30th September 2008. 1st January 2008 up to and including 31st December 2008 if farm has been registered with an adequate fencing certificate according to the Game Theft Act, 1991 (Act No. 105 of 1991). Eland may only be hunted in the Kestell district if the farmer has an adequate fencing certificate.</p>
<p>Common Duiker, Mountain Reedbuck, Steenbok, Cape Hare and Scrub Hare.</p>	<p>1st May 2008 up to and including 30th September 2008. Cape Hare and Scrub Hare will have a joint bag limit of three (3) hares per hunter per day.</p>
<p>Klipspringer and Grey Rhebuck.</p>	<p>1st May 2008 up to and including 30th September 2008. Animals may only be hunted on farms that have valid certificates of adequate fencing in accordance with the Game Theft Act, 1991 (Act No. 105 of 1991).</p>

<p>Bontebok, Blesbok, Blouwildebees, Bosbok, Gemsbok, Kameelperd, Rooihartebees, Rooibok, Rietbok, Burchell Sebra, Hartmann Sebra, Waterbok, Afrika Buffel, Springbok, Swartwildebees, Koedoe en Eland.</p>	<p>1^{ste} Mei 2008 tot en met die 30^{ste} September 2008. 1 Januarie 2008 tot en met 31 Desember 2008 vir grondeienaars in besit van 'n geldige omheiningsertifikaat soos bepaal in die Wilddiefstal Wet, 1991(Wet Nr. 105 van 1991). Elande mag slegs in die Kestell Distrik gejag word indien grondeenaar in besit is van 'n geldige omheiningsertifikaat.</p>
<p>Gryskuiker, Rooiribbok, Steenbok, Vlakhaas en Kolhaas.</p>	<p>1^{ste} Mei 2008 tot en met die 30^{ste} September 2008. 'n Getal van 3 Vlakhase en 3 Kolhase per jagter per dag word toegelaat.</p>
<p>Klipspringer en Vaalribbok.</p>	<p>1^{ste} Mei 2008 tot en met die 30^{ste} September 2008. Diere mag slegs gejag word op plase wat geregistreer is met 'n sertifikaat van voldoende omheining ooreenkomstig die Wet op Wilddiefstal, 1991 (Wet No. 105 van 1991).</p>
