Under the powers vested in me by section 16(1)(g), read with sections 6(3)(b)(ii) and 17 of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), and section 23(2)(a) of the Local Government: Municipal Demarcation Act, 1998 (Act No. 27 of 1998), I, **MJ MAFEREKA**, Member of the Executive Council responsible for Local Government and Housing in the Free State Province, hereby:-

- (a) include the area of jurisdiction of FSDMA19 into the Dihlabeng Local Municipality (FS192); and
- (b) amend clauses 19 and 34 of Provincial Notice No. 184 published in *Provincial Gazette* No.112 of 28 September 2000 to give effect to the boundary change of the Dihlabeng Local Municipality (FS192) in accordance with the Municipal Demarcation Board Notice No. 17 published in *Provincial Gazette* No. 2 of 18 January 2008, and after publication of Electoral Commission Notice No. 238 in *Provincial Gazette* No. 62 of 8 August 2008,

with effect from the date of the next municipal elections.
