- Die bepalings gelys in Bylae 2 is gewysig soos per die aangehegte kaarte.

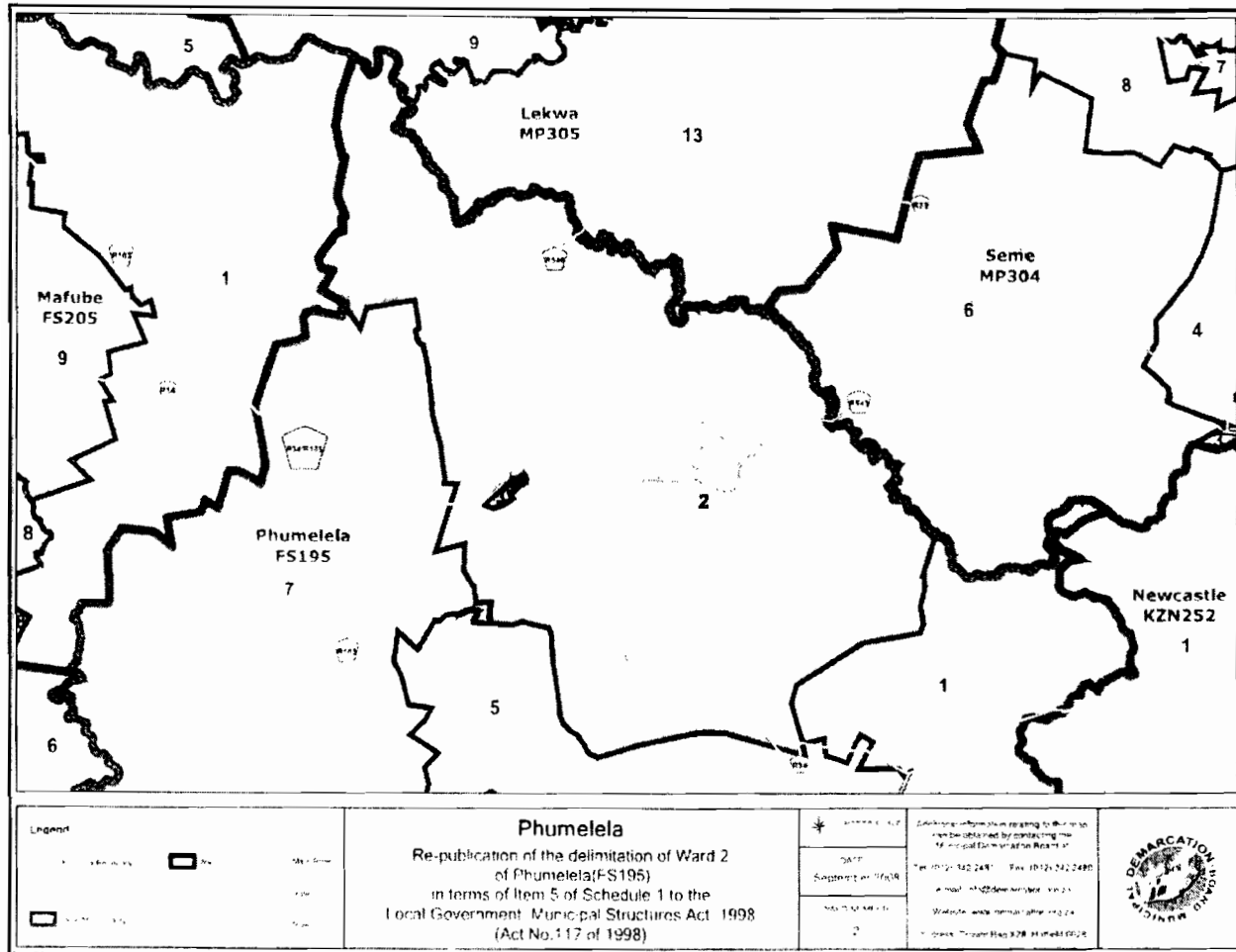

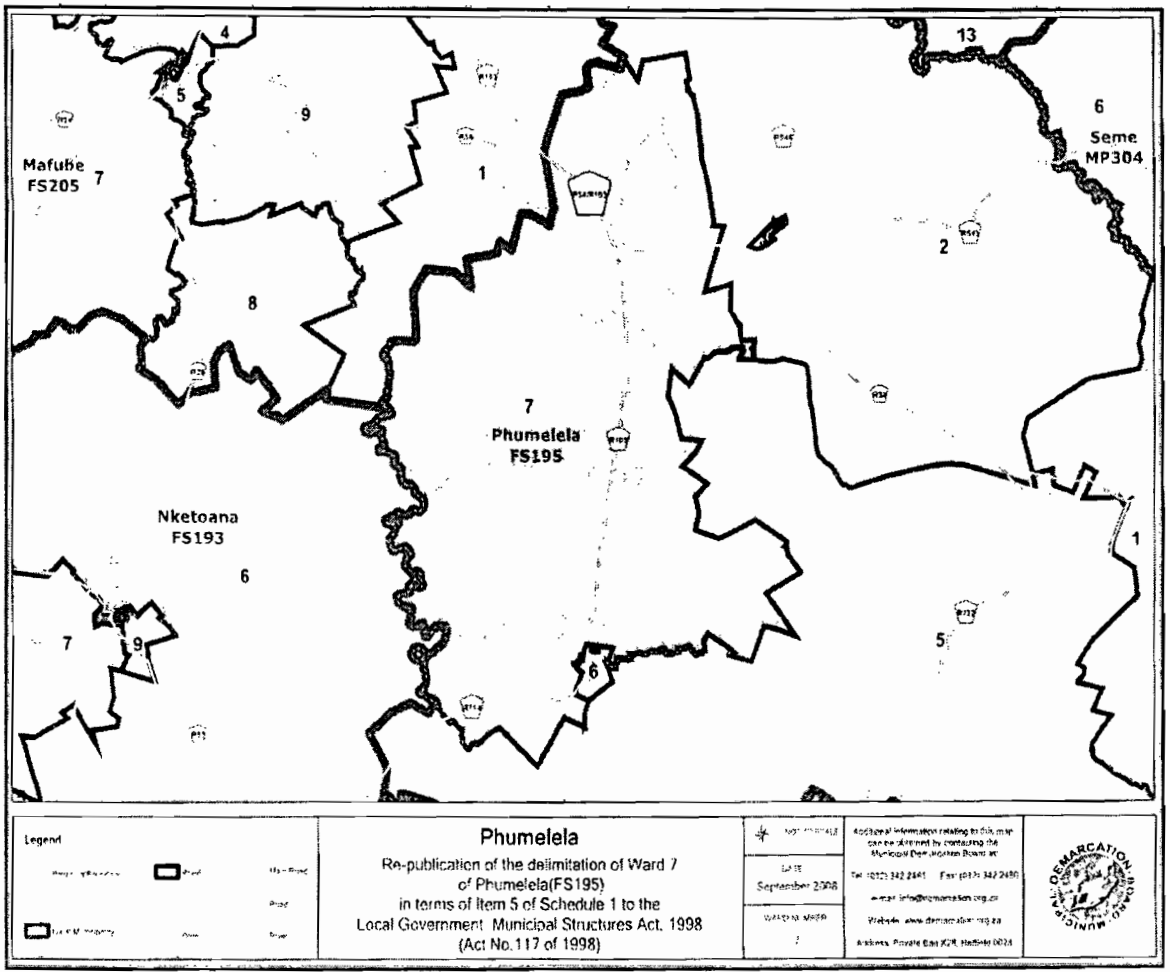
