By virtue of the powers vested in me by section 14(1) of the Townships Ordinance, 1969 (Ordinance No. 9 of 1969), I, M.J. Zwane, Member of the Executive Council of the Province responsible for Cooperative Governance, Traditional Affairs and Human Settlements, hereby declare the area represented by General Plan S.G. No. 946/2009 as approved by the Surveyor General on 9 July 2009 to be an approved township under the name Tswaraganang, Extension 3, subject to the conditions as set out in the Schedule.

3. CONDITIONS OF TITLE

The conditions of title as mentioned in par. 2 are as follows:

In favour of the Local Municipality of Tokologo.

3.1 This erf may only be used for dwelling purposes and only one house together with the necessary out buildings may be erected thereon. Provided that with the written consent of the Local Authority the following uses may be conducted as secondary uses.

- Places of public worship
- Places of instruction
- Social halls
- Sport and recreation purposes
- Institutions
- Medical suites and
- the practice of the occupants professions or trades which includes retail trade: provided that no secondary use may exceed the scale of the primary use and that the non residential uses shall not be noxious or a nuisance interfering with the amenity of the neighbourhood.

The local authority also has the authority to revoke any secondary use or have it terminated if it poses a nuisance to the people in the vicinity. The maximum allowable coverage on the erf is 60%, while the maximum height of 2 floors is allowed.

3.2 This erf may be used for business purposes only: provided that with the written consent of the local authority, the following uses may be conducted as secondary uses:

- Residential buildings
- Places of public worship
- Places of instruction
- Social halls
- Sport and recreational purposes
- Institutions

Provided further that no secondary use will exceed the primary use. The local authority also has the authority to revoke any secondary use or have it terminated if it poses a nuisance to the people in the vicinity.

The maximum allowable coverage on the erf is 70%, while the maximum height of 2 floors is allowed. Parking must be provided at the ratio of 2.5 parking bays per 100m² of business area.

3.3 This erf may be used for church purposes only: provided that with the written consent of the local authority, the following uses may be conducted as secondary uses.

3.2 Hierdie erf mag slegs vir besigheidsdoeleindes gebruik word: Met dien verstande dat met die plaaslike owerheid se toestemming enige van die volgende gebruike as sekondêre gebruike op die erf bedryf mag word:

- Residensiële geboue
- Plekke van openbare godsdiensoefening
- Plekke van onderrig
- Gemeenskapsale
- Sport en rekreasiedoeleindes
- Inrigtings

Met dien verstande verder dat nie enige van die sekondêre gebruike op groter skaal as die primêre bedryf gebruik mag word nie en dat die nie-residensiële gebruike nie hinderlik is of die bevalligheid van die omgewing nadelig raak nie.

The maximum allowable coverage on the erf is 70%, while the maximum height of 2 floors is allowed, (excluding a clock tower). Parking must be provided at the ratio of 1 parking bay per 6 seats.

- 3.4 This erf may be used as a park, sports and recreation facility and only buildings ancillary to the afore-mentioned may be erected on the erf.
- 3.5 This erf may be used for municipal purposes only, to servie the pipe lines and service situated below and above ground.
- 3.6 All the rights to minerals, precious stones and earth oil as defined in the Mineral Act, would be Municipal Property.
- 3.7 This erf is subject to a servitude 2m wide along any of the side and rear boundary.

This servitude is for the laying of any municipal services above or under ground and officials of the local authority will have access to these services at any reasonable time for purposes of maintenance and repair thereof. The local authority may relax these servitudes if it is of the opinion that it is not needed for services.
