DETERMINATION OF SALARIES AND ALLOWANCES OF MEMBERS OF EXECUTIVE COUNCIL AND MEMBERS OF PROVINCIAL LEGISLATURE

1. In terms of section 6(3) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) ("the Remuneration Act"), I, ES Magashule, Premier of the Free State Province, hereby determine that the annual salaries and allowances of the Members of the Executive Council and the Members of the Provincial Legislatures shall be with effect from 1 April 2008 as set out in Proclamation 52 in *Government Gazette* 31597 of 12 November 2008 read with Proclamation 80 in *Government Gazette* 32739 of 23 November 2009.

1. In terms of section 6(3) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) ("the Remuneration Act"), I, ES Magashule, Premier of the Free State Province, hereby determine that the annual salaries and allowances of the Members of the Executive Council and the Members of the Provincial Legislatures, excluding the Premier, shall be with effect from 1 April 2009 as set out in Proclamation 79 in *Government Gazette* 32739 of 23 November 2009.
