### INVITATION FOR NOMINATIONS OF PERSONS TO SERVE ON THE APPEAL PANEL

1. Under the powers vested in me by section 43(5) of the National Environmental Management Act, 1998 (Act No. 107 of 1998) as amended, I, MA Dukwana, Member of the Executive Council responsible for Economic Development, Tourism and Environmental Affairs in the Province, hereby request nominations for candidates to serve on the Appeal Panel.

  - 4.2 Have knowledge of, and expertise in, environmental affairs (two members to be appointed).
