### DECLARATION OF THE SNEEUWBERG PROTECTED ENVIRONMENT IN TERMS OF THE NATIONAL ENVIRONMENTAL MANAGEMENT: PROTECTED AREAS ACT, 2003 (ACT NO. 57 OF 2003)

Notice is hereby given by the Member of the Executive Council (MEC) for Economic and Small Business Development, Tourism and Environmental Affairs for the Free State Province, the Honourable Mr S.M. Mashinini, in terms of section 28(1)(a) and (b) of the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003) of the declaration of the **SNEEUWBERG PROTECTED ENVIRONMENT** on the area defined in the Schedule hereto.

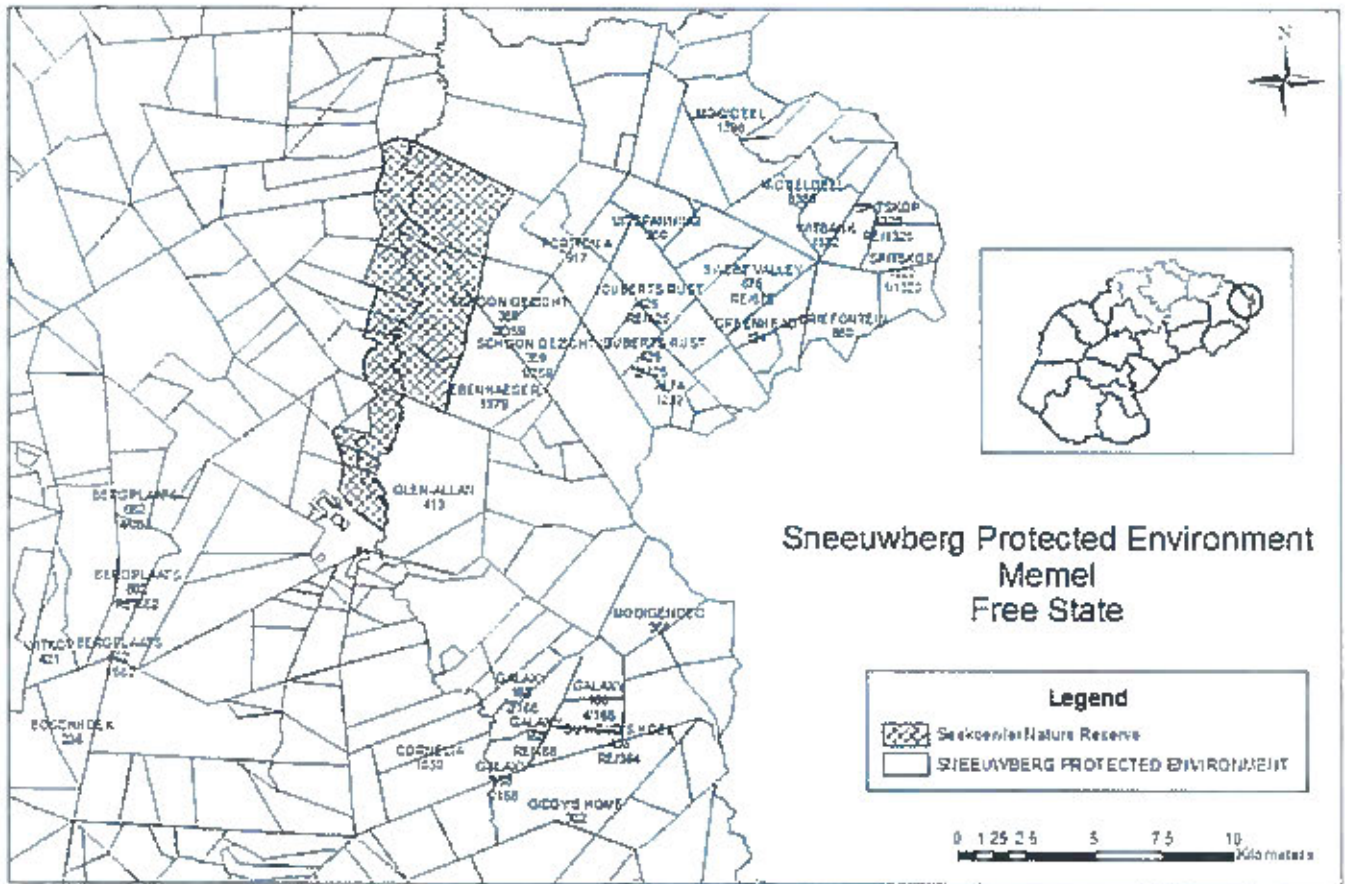
- **Name of the Protected Area** (section 28(1)(b) of the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003)): **SNEEUWBERG PROTECTED ENVIRONMENT.**
- **Category of Protected Area** (section 28(1)(a) of the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003)): **PROTECTED ENVIRONMENT.**
- **Assignment of Management Authority** (section 38(2)(b) of the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003)): The **SNEEUWBERG PROTECTED ENVIRONMENT LANDOWNERS ASSOCIATION** is hereby assigned as the **MANAGEMENT AUTHORITY** for the **SNEEUWBERG PROTECTED ENVIRONMENT.**
- **Purpose of the Declaration:**
  - to regulate the area as a buffer zone for the protection and conservation of the Seekoievlei Nature Reserve (Provincial Nature Reserve);
  - to enable the landowners to take a collective action to protect the unique and threatened ecosystems (grasslands and wetlands) and the biodiversity associated with the **SNEEUWBERG PROTECTED ENVIRONMENT** and the region in general;
  - to ensure that the provision of the ecosystems services deriving from the area is sustained.


