Under the powers vested in me by section 2 of the Removal of Restrictions Act, 1967 (Act No. 84 of 1967) I, S.H. Ntombela, Member of the Executive Council of the Province responsible for Co-operative Governance, Traditional Affairs and Human Settlements, hereby alter the conditions in Proclamation No. 09 of 2011, promulgated in Provincial Gazette No. 36 of 22 July 2011, pertaining to Portion 8 of the farm Roderick's Park 2834, Bloemfontein, Extension 194, by the amendment of Condition of Establishment A.3 on page 4 in the said Provincial Gazette to read as follows:
